Composition: Mixture of 10 mM Tris Base and Tris-HCl, 1 mM EDTA Disodium Dihydrate, $\mathrm{pH} 7.4 \pm 0.2$. Prepared in 18.2 megohms-cm $\pm 1$ water and autoclaved at $15 \mathrm{psi}\left(121^{\circ} \mathrm{C}\right)$ for 30 minutes on liquid cycle and/or filtered through 0.22-micron filter.
