### **SECTION 3- COMPOSITION/INFORMATION ON INGREDIENTS**

**Composition:** Mixture of 10 mM Tris Base and Tris-HCl, 1 mM EDTA Disodium Dihydrate, pH 7.4 ± 0.2. Prepared in 18.2 megohms-cm ± 1 water and autoclaved at 15 psi (121°C) for 30 minutes on liquid cycle and/or filtered through 0.22-micron filter.

### **SECTION 4 - FIRST-AID MEASURES**

#### **4.1 Description of first aid measures**
