### SECTION 3- COMPOSITION/INFORMATION ON INGREDIENTS

**Composition:** Mixture of 10 mM Tris Base, 1 mM EDTA Disodium Dihydrate, pH 8.0  $\pm$  0.2. Prepared in 18.2 megohms-cm  $\pm$  1 water and autoclaved at 15 psi (121°C) for 30 minutes on liquid cycle and/or filtered through 0.22-micron filter.
