### **SECTION 3 - COMPOSITION/INFORMATION ON INGREDIENTS**

**Composition:** Mixture of 50 mM Tris Base and Tris-HCl, 150 mM Sodium Chloride, 0.5% Sodium Deoxycholate, 0.1% Sodium Dodecyl Sulfate (SDS), 1% Nonidet P-40 Substitute, 5 mM EDTA, pH 7.4 ± 0.20. Prepared in 18.2 megohms-cm ± 1 water and filtered through 0.22-micron filter.

**4.1 Description of first aid measures**
