### **SECTION 3 - COMPOSITION/INFORMATION ON INGREDIENTS**

**Composition:** Mixture of 100 mM Tris Base and Tris-HCl, 300 mM Sodium Chloride, 1% Sodium Deoxycholate, 0.2% SDS, 2% Nonidet P-40 Substitute, pH 7.4 ± 0.20. Prepared in 18.2 megohms-cm ± 1 water and filtered through 0.22-micron filter.

#### **4.1 Description of first aid measures**
