### **SECTION 3- COMPOSITION/INFORMATION ON INGREDIENTS**

**Composition:** Mixture of 1 M Tris Base and Tris-HCl, 3 M Sodium Chloride, 2% Tween-20, pH 7.4 ± 0.2. Prepared in 18.2 megohms-cm ± 1 water and autoclaved at 15 psi (121°C) for 30 minutes on liquid cycle.
