SECTION 4 - FIRST-AID MEASURES

4.1 Description of first aid measures

General advice: Consult a doctor and show this safety data sheet.

- **7.1 Precautions for safe handling:** Use in a chemical fume hood, with air supplied by an independent system. Avoid inhalation, contact with eyes, skin and clothing.
