4.1 Description of first aid measures

4.2 Most important symptoms and effects, both acute and delayed: To the best of our knowledge, the chemical, physical and toxicological properties have not been thoroughly investigated.

SECTION 5 - FIRE FIGHTING MEASURES

SECTION 6 - ACCIDENTAL RELEASE MEASURES

8.2 Exposure Controls
